

## **Official Rules for the oneAPI Hands-on Lab using the Intel® AI Analytics Toolkit:**

These rules (the “Official Rules”) govern the various contest activities (the “Contest”) conducted as part of the **oneAPI Hands-on Lab using the Intel® AI Analytics Toolkit** and set out the terms and conditions between Intel Semiconductor (US) LLC (“Organizer”) and Kestone Integrated Marketing Services - (A Division of CL Educate Limited) ( “Kestone Integrated Marketing Services - (A Division of CL Educate Limited)”, collectively referred as “us/we”) and each participant (“participant” or “you”). A submission to the Contest constitutes your acceptance of the Official Rules.

**1. The Contest:** Participants must meet the Entry Requirements set out below. You will be asked to enter contact information so that Kestone Integrated Marketing Services - (A Division of CL Educate Limited) can contact you for Contest announcements and prize distribution. Your contact information will be treated in accordance with Intel Privacy Notice.

Kestone Integrated Marketing Services - (A Division of CL Educate Limited) is facilitating the Contest as part of the activities of the oneAPI Hands-on Lab using the Intel® AI Analytics Toolkit from 09:00 AM IST on **3<sup>rd</sup> November 2023** to **06:00 PM IST on 2<sup>nd</sup> December 2023** (“Contest Period”) (all time zones are based on India Standard Time).

**2. Eligibility:** The Contest is open to residents of India. Participants must be 18 years of age or older. Employees, officers and representatives (and members of their immediate families and those living in the same household of each) of Intel Semiconductor (US) LLC, its parents, subsidiaries and affiliated companies, Kestone Integrated Marketing Services, oneAPI Certified Instructors, Intel Software Innovators, Intel Student Ambassadors, advertising and promotion agencies and any company involved in the design, execution, production or judging of this promotion (“Contest entities”) are ineligible.

**To participate in the “oneAPI Hands-on Lab using the Intel® AI Analytics Toolkit” - you must meet the following eligibility criteria:**

- Working professionals (Participants those who have graduated and have valid work experience of a minimum 06 months in a company) -AI Developers, AI Enthusiasts, Data Scientists, ML Engineers, Programmers, Freelancers: Participants who have graduated, are self-employed, and are not committed to a particular employer for a permanent job. These participants are not confined to any particular industry, start-ups and research scholars.
- Participants who have completed their education, operate independently and are not committed to a specific employer for permanent employment. This inclusivity transcends industry boundaries.

**3. Contest Entry Limit:** There is a limit of one (1) entry per participant for the Contest. Participants submitting multiple entries will be disqualified.

. **Ownership and Publicity:** Organizer does not claim ownership of your submission to the Contest; but by submitting an entry, you are granting Organizer and its affiliated companies the following worldwide, non-exclusive, perpetual, irrevocable, royalty-free, unconditional, fully paid-up rights: (1) to make, have made, use, copy, reproduce, modify, and create derivative works of the contributions, (2) to publicly perform or display, import, broadcast, transmit, distribute (directly and indirectly through multiple tiers), license, offer to sell and sell, rent, lease, or lend copies of the contributions (and derivative works thereof), (3) to sublicense to third parties the foregoing rights, including the right to sublicense to further third parties, and (4) to publish your name or alias in connection with this Contest and your contributions. Participants understand and agree that their submissions may be posted and publicly viewable. By providing a submission, you grant the Organizer the right, except where prohibited by law, to use your name for promotional purposes in promoting or publicizing the Contest. Organizer, however, does not have any obligation to use the winning Entries for any purpose.
